### **SUB: REGULARIZATION OF ENCROACHMENT BEYOND 25% OF ALLOTMENT.**

As per decision taken in the 101<sup>st</sup> meeting of Board of Directors of IDCO held on 29.5.2015, encroachments beyond 25% of original allotment will be regularized in eligible cases on realization of either bench-mark rate or three times of prevailing industrial land rate whichever is higher.
