**Sub: Application of Industry status to Warehousing & Cold Chain.**

In pursuance of the resolution passed in the 115<sup>th</sup> meeting of the Board of Directors of IDCO held on 10.1.2019, it has been decided to consider Warehousing and Cold Chain at par with industry and the land rate for allotment of land to Ware Housing and Cold Chain projects in any Industrial Estate / Area will be with the industrial land rate. Further the allotment of land to these projects will be within 15% of the allotable area in the said Industrial Estate / Area.

This circular shall come into force with effect from 10.1.19.
