NOTIFICATION

In exercise of the power conferred under Section 59 of the Odisha Industrial Infrastructure Development Corporation Act, 1980 (Odisha Act 1 of 1980), the Board of Directors is pleased to make further amendment to the Odisha Industrial Infrastructure Development Corporation (Method of Recruitment and Conditions of Service) Regulations, 2019, namely:-

1. Short title and commencement:-

- 1) These Regulations may be called the Odisha Industrial Infrastructure Development Corporation (Method of Recruitment and Conditions of Service) (Amendment) Regulations, 2022.
- 2) These Regulations shall come into force from the date of publication in the Odisha Gazette.

2. In the Odisha Industrial Infrastructure Development Corporation (Method of Recruitment and Conditions of Service) Regulations, 2019, for sub-regulation (2) of Regulation 21, the following sub-regulation shall be substituted, namely:-

"(2) A person must have put in 5 years of service in the feeder post or grade so as to consider him for the post of higher post or grade:

Provided that experience criteria of 5 years can be relaxed to not less than half of the stipulated period in case of promotion to the next higher post or grade where such relaxation is considered necessary and expedient to do so:

Provided further that this relaxation can only be availed by any employee only once during his whole career".


