Notification

In pursuance to the Clause-39 of the Odisha Industrial Infrastructure Development Corporation (Amendment) Act 2020, the Authority do hereby notify that the Customers availing supply of water from IDCO, shall be notified/intimated in advance as prescribed in conditions below prior to the outage in supply:

1. In **emergency conditions** such as repair and restoration of broken pipeline, the Customers shall be intimated 24 hrs. (twenty-four) in advance prior to the commencement of repair and restoration activity ensuring the storage of water for their routine work.
2. **In case of any planned outage**, such as augmentation and integration of new supply line in the system, a minimum 1 (one) month prior intimation shall be notified to the Customers so that they can plan their work accordingly during the planned shutdown period.

The above notice/intimation shall be displayed on **GOiPAS** portal in addition to the IDCO's website.

The order shall come into force with immediate effect.
