The situation arising out of the COVID-19 Pandemic affected almost all industrial projects under implementation due to frequent periods of shutdowns, prolonged lockdowns, disruption of movement of goods and manpower apart from causing a general economic slowdown. It is observed that this adverse situation has led to time overrun in implementation of projects. Though there is a provision of delay condonation of project implementation period under section 5.2(e) of IPR 2015, it would be impractical to deal with delay condonation of such large number of projects on a case-to-case basis.

Therefore, the Government of Odisha has been pleased to grant a general extension of two years for completion to industrial projects under implementation in the period dt.01/03/2020 to dt. 28/02/2022. The industrial units otherwise eligible can avail incentives as per the provision in IPR 2015 and/or respective sectoral Policy in accordance with the respective operational guidelines.

This will come into force with immediate effect.
